### **1. MAY 2012 EXAMINATIONS**

Registration for May 2012 examinations is open and candidates wishing to register for exams are asked to follow the established protocols to do so.

Candidates with qualifications lower than an Accounting Degree enrolled in the CPA Program under the old structure are advised to complete their remaining units over the next six examination sittings; failing which they will be streamed into the Certified Accounting Technician (CAT) stream with equivalent credits for exams already passed. Candidates under this category with queries requiring assistance on the course sequencing are asked to consult us for assistance.

Candidates are encouraged to take one paper at a time in order to thoroughly master the subject knowledge and pass the paper with good results.

### **2. SPONSORS FOR EXAMINATION PRIZES**

There are three subjects in the Certified Accounting Technician (CAT) category that require new sponsors for the exam prize awards. These are:

- Business Finance
- Accounting Principles & Concepts
- Intro to Business Law

### **4. RESIGNATION OF IT ADMINISTRATOR – NATHAN GANAK**


